



Energy Efficiency Improvements for Manufactured Homes

Vermont Gas Systems (VGS) is offering a turnkey program to help homeowners reduce their energy costs for manufactured homes. These energy efficiency upgrades include duct sealing and adding roof & belly insulation. These improvements will meet or exceed the minimums required as outlined in the Vermont TEC Manual 2020 for Mobile Homes.

Our program rebates are:

<u>Efficiency Upgrade</u>	<u>VGS Rebate</u>
Duct Sealing + Roof & Belly Insulation	75% of cost up to \$4,875
Duct Sealing + Belly Insulation	75% of cost up to \$2,850
Duct Sealing + Roof Insulation	75% of cost up to \$2,850

Typical upgrades may include:

- ⇒ *Comprehensive air sealing in the attics/roof shall include the sealing of all wall to ceiling sheet rock joints.*
- ⇒ *Attic insulation shall be upgraded to R40+ with open-blown fiberglass or as space permits after all air sealing or other repairs in the attics have been completed.*
- ⇒ *Insulating the belly or floor system using R19 chopped fiberglass. The blown insulation shall not be dense-packed.*

Upon completion of the improvements:

- VGS may have an energy auditor visit your home to inspect the completed work at no cost to you
- VGS will pay the above rebate for approved work completed before 12/31/2023.
