

IMPORTANT NOTICE REGARDING UPCOMING RATE CHANGES

For over 50 years, VGS has maintained competitive and affordable rates for its 55,000+ customers. As we work to enhance our customer service and make investments in safety and Vermont's clean energy future, we are committed to keeping those rates low for current and future customers. Thus, we want to let you know about proposed rate changes.

Purchased Gas Adjustment: Case No. 23-2944-TF

On August 29, 2023, VGS filed a request with the Vermont Public Utility Commission ("Commission") for an in increase in the Natural Gas charge of 0.3%, equivalent to an overall firm rate increase of 0.12%. The effective date of this change is dependent on the regulatory review process but it is anticipated to take effect with bills rendered in November 2023. A typical residential customer pays about \$1,545.12 a year for natural gas. With this change, that amount would increase by about \$1.71/year or approximately \$0.14/month.

Overall Rate Increase: Case No. 23-0561-TF

On February 15, 2023, VGS filed a request with the Commission for an overall rate increase forecasted to be 0.1%. The overall rate change is comprised of a forecasted 14.9% decrease in the Natural Gas Charge portion of your bill and a 10.7% increase in the Daily Access and Distribution Charges. To limit the increase in the Daily Access and Distribution Charges to 10.7%, VGS has also requested that the Commission allow us to return to customers the entire remaining balance of the System Expansion and Reliability Fund ("SERF") that the Commission authorized in 2011 for future use to help bring natural gas service to more Vermonters. The SERF balance is approximately \$670,000.

Please note that the decrease in the Natural Gas Charge portion of your bill is forecasted, and is based on rates in effect as of February 15, 2023. The actual percent change will depend on natural gas costs at the time of the November 2023 rate change and, under our current regulatory framework, the Natural Gas Charge will continue to change quarterly until then. Quarterly changes to the Natural Gas Charge are requested in proceedings separate from this rate request.

As we work toward maintaining our core values of safety, climate, customers, and culture, we are committed to keeping our rates low and stable for current and future customers. Pending regulatory approval, the rate components will be adjusted as follows:

^{*}This rate change is indicative, not proposed. Proposed changes to the Natural Gas Charge and voluntary RNG Adders will be filed with the Commission quarterly.

Note that the rates proposed in the overall rate request filing will be affected by VGS's three-year Alternative Regulation Plan. The Plan, as recently approved by the Commission in Case No. 22-5085-PET, includes the ability to spread the increase in the Daily Access and Distribution Charges over the three-year term of the Plan. When the Commission issues its order regarding the overall rate request, we will update this customer notice accordingly.

VGS has submitted the rate request and its proposed Purchased Gas Adjustment via ePUC, the Commission's online case and document management system. Interested customers can view the filings at at https://epuc.vermont.gov/. Customers are encouraged to provide comments to the Commission at any time. Comments regarding these filings may be submitted to the Commission via ePUC under Case No. 23-0561-TF (rate request), and Case No. 23-2944-TF (Purchased Gas Adjustment). [†] This charge only applies to customers participating in the voluntary renewable natural gas program.
