- ★ **75% rebate** on duct sealing, roof, and belly insulation up to **\$4,875**
- ★ **75% rebate** on duct sealing and roof (or belly) insulation up to **\$2,850**
- ★ 100% rebate is available for low-income qualified customers

**0% APR financing** on weatherization project (project financing can also include qualifying natural gas equipment and health and safety work required to perform the project)

- ★ 1-5 year terms, loan amounts up to \$20,000
- ★ Longer term loans available, but APR and other terms may change
- ★ Natural gas equipment financed at these rates is not eligible for additional rebates.

(Annual Percentage Rate)

**5.99% APR financing** on weatherization project (project financing can also include other non-weatherization project costs desired by owner)

- ★ 1-5 year terms, up to \$20,000
- ★ Longer term loans available, but APR and other terms may change
- ★ Natural gas equipment financed at these rates is eligible for additional rebates.

## Terms & Conditions

- To qualify for incentives and financing, a weatherization project must be performed by a BPI-certified contractor and achieve a minimum air leakage reduction of 10%. To find a BPI contractor please visit: <https://www.efficiencyvermont.com/find-contractor-retailer>
- Multi-family home incentives apply to 4 units or less.
- Customers can phase their improvements in over time if desired, however the total rebate cap is fixed for individual properties
- Financing is subject to approval by Green Mountain Credit Union.
