



IMPORTANT NOTICE REGARDING UPCOMING RATE CHANGES

For over 50 years, VGS has maintained competitive and affordable rates for its 56,000+ customers. As we work to enhance our customer service and make investments in safety and Vermont’s clean energy future, we are committed to keeping those rates low for current and future customers. Thus, we want to let you know about proposed rate changes.

Purchased Gas Adjustment: Case No. 26-1051-TF

On May 27, 2026, VGS filed a request with the Commission for a decrease in the Natural Gas charge of 5.9%, which results in an overall firm rate decrease of 1.89%. The effective date of this change is dependent on the regulatory review process, but it is anticipated to take effect with bills rendered on and after August 4, 2026. With these changes, a typical residential customer will pay about \$1,748.40 a year for natural gas which is a decrease of about \$29.89/year or approximately \$2.49/month.

As we work toward maintaining our core values of safety, climate, customers, and culture, we are committed to keeping our rates low and stable for current and future customers. Pending regulatory approval of the Purchased Gas Adjustment, rates will be adjusted as follows:
